I have been made aware, through an e mail, that there is doubt about the honesty of this council.

It is a very serious allegation to make and I have had to take advice from the Society of Local Council Clerks on how this allegation should be addressed.

If any of you have doubts about council business and how it is conducted and hold the belief that — as the e mail says - quote: *There are lots of untruths within the council.*, then it must be disclosed and investigated for the integrity of the parish council, and please note — it says *lots of untruths* — many lies, not just one. All councillors need to know what these alleged lies are, so that this can be answered.

This council has the highest of professional standards and a remark like this made within the community could mean the complete dissolving of the Parish Council. At this time, I do not intend disclosing any details but if this occurs again I will have no option but to report it to the Cambridgeshire Standards Committee for investigation and the council will be dissolved.

Linked with this from people who read the minutes, they ask why the council is so much against any proposal made for the parish cemetery for which Sylvia Tooke and her council worked tirelessly and achieved for the people of Leverington. I have explained that it is council's decisions but they cannot understand why playground facilities are passed and not cemetery. This council achieved the development of phases 2,3, and 4 and should be proud of that.

I will have to record this minute as short and concise as possible. Be aware of the content of any e mail you write or receive referring to council business whether it be to other councillors, ex councillors or parishioners. You will be criticising yourself.
