This cemetery is designated a <u>Lawn Cemetery</u>. <u>Inter</u>ment fees are for an **EARTHEN BURIAL**.

The right to erect a memorial stone or cross is only permitted in respect of a granted/purchased exclusive right of burial. For everyone from outside the village, ALL fees will be doubled. For clarification, contact the council.

1. <u>Interment Fees into an ashes chamber</u> (includes Cemetery Safety Inspection).

Monday to Friday between 10.00am and 3.30pm.

No interments (burial or cremated remains) are allowed on Bank holidays, Sundays or other religious holidays

For the interment of cremated remains into a chamber 2 x 2	280
For the Exclusive Rights to the Chamber	280
To erect a tablet on the chamber (paid to the stone mason)	75
To inter cremated remains into an earthen grave at the same time as a burial	200
To inter cremated remains into an existing earthen grave (maximum 2 urns) in each	280
To insert further cremated remains into an existing chamber (one only. Maximum is two to a chamber)	280
To choose the chamber.	100
To remove tablet to insert new inscription	75

The right to erect a memorial tablet is only permitted in respect of a granted/purchased exclusive right of ashes burial. For everyone living outside the village, ALL fees will be doubled. For clarification, contact the council.

To reserve an ashes chamber	400
Exhumation of cremated remains – minimum charge	400
Transfer of Ownership of Exclusive Rights	100
(if the owner is deceased, completion within one month)	75
A Saturday interment incurs an additional charge	250

Reservations (EROB). The amount of fee paid for a reservation /EROB will need to reflect the current fee at the time of death. The difference between fee paid and current fee will be required.

IF THE EXCLUSIVE RIGHT OF BURIAL is not purchased, **no** tablet will be allowed.

	For the Right to erect Commemorative Plaques.	
	(Proof of the deceased must be seen by the council representative before any plaque is erected).	
1.	On the Wall of Remembrance – Phase One	35
2.	On the Wall of Remembrance – Phase Four (contact the Burial Authority)	Contact council
3.	To erect a plaque on the bench in memory of a person or persons.	Contact council
5.	Short Notice Fee. Interment arrangements required with less than 3 working days	300

	VAULT REQUEST FOR AN EARTHEN GRAVE. BURIAL AUTHORITY POLICY.	
1.	No vaults can be dug between 1 st November and 1 st March in any year because of the water table.	
2.	Vaults can only be constructed on the end of a row designated by the Burial Authority. The plot cannot be chosen.	
3.	Because of the extra administration and larger plot required and also the extension of the EROB, a payment, in advance, of JD £750 is required.	750
4.	This is extra to the burial and Exclusive Right of Burial fees.	1364

For a certified copy of an entry of burial in the Register	100
For a search in the register for a period of one year	100
For each additional year	100
