This form must be signed by his / her siblings. This form should be attached to the statutory declaration before the declaration is made and reference to this form should be made within the declaration

The Council will accept the Funeral Director or a Leverington Councillor as a witness signatory. Other witnesses may be professional persons but profession must be stated.
